

S.L.A.R. Membership Categories:

DR	Designated REALTOR®- Primary Broker for the office. – Can hold Broker, Broker Officer, Broker Associate, Broker Partner or Appraisers license.
DRC	Designated REALTOR® Commercial- Primary Broker for the office with commercial access only. (ADDITIONAL \$100.00 for Commercial Dues Assessment)
DR3	Designated REALTOR® Residential and Commercial- Primary Broker for the office with residential and commercial access. (ADDITIONAL \$200.00 for Residential/Commercial Dues Assessment)
DRS	Designated REALTOR® Secondary- Primary Broker for the office, but is a primary member with another association.
DRCS	Designated REALTOR® Commercial Secondary- Primary Broker for the office with commercial access only. Has a primary membership with another association.
DRW	Designated REALTOR® Dual- Primary Broker for the office. Has two memberships with SLAR.
DWC	Designated REALTOR® Dual Commercial- Primary Broker for the office. Has two memberships with SLAR, however his "DUAL" has commercial access only.
R	REALTOR®- Someone who has a Broker Associate license or Broker Officer license but is not the "Primary Broker" has to have an "R" membership. Also- any "Broker Sales license" that is an office manager must be an "R".
RC	REALTOR® Commercial- Someone who has a Broker Associate license or Broker Officer license but is not the "Primary Broker" has to have an "R" membership. Also- any "Broker Sales license" that is an office manager must be an "R". Has commercial access only. (ADDITIONAL \$100.00 for Commercial Dues Assessment)
R3	REALTOR®: Residential and Commercial- Someone who has a Broker Associate license or Broker Officer license but is not the "Primary Broker" has to have an "R" membership. Also- any "Broker Sales license" that is an office manager must be an "R". Has residential and commercial access. (ADDITIONAL \$200.00 for Residential/Commercial Dues Assessment)
RS	REALTOR® Secondary- Someone who has a Broker Associate license or Broker Officer license but is not the "Primary Broker" and has primary membership with another association.
RCS	REALTOR® Commercial Secondary- Someone who has a Broker Associate license or Broker Officer license but is not the "Primary Broker" and has primary membership with another association. Has commercial access only.
RW	REALTOR® Dual- Someone who has a Broker Associate license or Broker Officer license but is not the "Primary Broker" who has two memberships with SLAR.

RWC	REALTOR® Dual Commercial- Someone who has a Broker Associate license or Broker Officer license but is not the "Primary Broker" who has two memberships with SLAR, however his "DUAL" membership is commercial only.
RA	REALTOR® Associate- Someone who has a Broker-Sales license or Salesperson license.
RAC	REALTOR® Associate Commercial- Someone who has a Broker-Sales license or Salesperson license. Has commercial only access.
RA3	REALTOR® Associate: Residential and Commercial- Someone who has a Broker-Sales license or Salesperson license. Has residential and commercial access. (ADDITIONAL \$200.00 for Residential/Commercial Dues Assessment)
RAS	REALTOR® Associate Secondary- Someone who has a Broker-Sales license or Salesperson license. Has a primary membership with another board.
RACS	REALTOR® Associate Commercial Secondary- Someone who has a Broker-Sales license or Salesperson license. Has a primary membership with another board. Commercial access.
RAW	REALTOR® Associate Dual- Someone who has a Broker-Sales or Salesperson license and has two memberships with SLAR.
RAWC	REALTOR® Associate Dual Commercial- Someone who has a Broker-Sales or Salesperson license and has two membership with SLAR. Commercial Access
A1	Affiliate- Member with SLAR that does not have an Real Estate License or Appraiser License.
A1W	Dual Affiliate- (see affiliate) has two memberships with SLAR.
A13	Affiliate Residential/Commercial- (see Affiliate) has both residential and commercial access.
A2	Second Affiliate- Member with SLAR who is not the first affiliate and does not have a Real Estate License or Appraiser License.
A23	Second Affiliate Residential/Commercial- Member with SLAR who is not the first affiliate and has residential and commercial access.
