SECONDARY MEMBERSHIP APPLICANTS:

Assuming you enroll in local and not state association membership, you'll pay the St. Louis REALTORS® Dues, Building Fund, and St. Louis REALTORS® Application Fee. If you elect to purchase MLS, you'll owe MARIS Subscriber and Application Fees. If you already have the Supra eKEY, adding cooperating access to your existing Supra app is included with a local membership.

IF YOU ARE REINSTATING YOUR MEMBERSHIP:

There are no charges to reactivate membership within 30 days of inactivation.

After 30 days, *and* if you paid the current year's Dues, your charges are: St. Louis REALTORS® Reinstatement Fee of \$35 for REALTORS® or \$60 for Designated REALTORS®, the MLS and Supra eKEY Activation Fee, and the MLS Quarterly Subscriber and Supra Monthly eKEY fee.

If you last paid 2025 Dues, you will pay the full 2026 Annual Dues, the St. Louis REALTORS®, MLS, and Supra eKEY Activation Fee, as well as the MLS Subscriber and Supra eKEY fee. The MR® Application Fee is not applicable.

If you last paid 2024 Dues, you will pay prorated Dues as displayed above, the St. Louis REALTORS®, MLS and Supra eKEY Activation Fee in addition to the MLS Subscriber and Supra eKEY Fees. The MR® Application Fee is reduced to \$100.

If you last paid Dues before 2024, you are considered a new applicant, and the fees apply as displayed above.
